

# TURBO-Lease

## TURBO-Lease™ End User License Agreement

This software program, including any documentation and media, (the "Software") is the proprietary product of Better Programs, Inc. ("BPI") and is protected by copyright laws. The Software is licensed (not sold) and the use of the Software is governed by the terms of this Software License Agreement (the "Agreement"). If for any reason the Licensee does not agree to the terms of the Agreement, Licensee will return the Software to BPI within 30 days of the date of the purchase for a full refund.

**License Grant.** BPI grants to Licensee, and Licensee accepts, a nontransferable, nonexclusive license to use the Software in machine readable, object code form, only as authorized in the License Agreement. Licensee may install only one copy, or any prior version on a single storage device such as a network server. The product may then be run on other computers over an internal network or accessed remotely. Licensee may make copies of the written documentation, which accompanies the Software, in support of the authorized use of this BPI software product. Licensee also may make copies of the Software for backup or test purposes. Except as authorized under this paragraph, no copies of the Software or any portions thereof may be made by Licensee or any person under Licensee authority or control. Licensee agrees that Licensee will not assign, sublicense, transfer, pledge, lease, rent or share Licensee rights under this Agreement. Licensee further agrees not to modify, adapt, loan, distribute, network or create derivative works based upon the Software or any part thereof. Licensee acknowledges and agrees that the Software contains trade secrets and that Licensee may not reverse assemble, reverse compile, reverse engineer, or otherwise translate or reduce the Software to human-perceivable form.

**BPI's Rights.** Licensee acknowledges and agrees that the Software and documentation are the proprietary products of BPI under U.S. copyright law. Licensee further acknowledges and agrees that all right, title and interest in and to the Software, including associated intellectual property rights, are and shall remain with BPI. This Agreement does not convey to Licensee an interest in or to the Software, but only a limited right of use revocable in accordance with the terms of this Agreement. TURBO-Lease is a registered trademark of BPI. No right, license or interest to such trademark is granted hereunder, and Licensee agrees that no right, license or interest shall be asserted by Licensee with respect to such trademark.

**License Fee.** The license fee paid by Licensee is in consideration for the license granted under this Agreement.

**Term.** The Agreement is effective upon purchase of the Software License and shall continue until terminated. BPI may terminate this Agreement upon the breach by Licensee of any term hereof. In such event, the Licensee must destroy all copies of the software product.

**Limited Warranty.** BPI warrants, for Licensee's benefit alone, for a period of thirty (30) days from the commencement of this Agreement (the "Warranty Period") that the materials or media in which the Software is contained is free from defects in material and workmanship. If during the Warranty Period a defect in the Software appears, Licensee may return the Software to BPI for replacement at no charge. Licensee agrees that the foregoing constitutes Licensee's sole and exclusive remedy for breach by BPI of any warranties made under this Agreement. EXCEPT FOR THE WARRANTIES AS SET FORTH ABOVE, THE SOFTWARE IS LICENSED "AS IS," AND BPI DISCLAIMS ANY AND ALL OTHER WARRANTIES, REPRESENTATIONS, CONDITIONS OR GUARANTEES OF ANY KIND WHATSOEVER EITHER EXPRESS OR IMPLIED BY LAW (IN CONTRACT OR TORT) OR CUSTOM, INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. **Limitation of Liability.** BPI's cumulative liability to Licensee or any other party for any loss or damages resulting from any and all claims, demands or actions arising out of or relating to this License Agreement (whether in contract, tort or otherwise) shall not exceed the license fee paid to BPI for use of the Software. In no event shall BPI be liable for any indirect, incidental, consequential, special, or exemplary damages, even if BPI has been advised of the possibility of such damages, including, but not limited to, lost profits or savings, loss of use or failure of Software, costs of substantiated services, down time or delay costs, or damages and expenses arising out of third party claims, regardless of the form of action, whether in contract, tort or otherwise, and whether or not such damages were foreseen or unforeseen.

**Governing Law.** This Agreement shall inure to the benefit of BPI, its successors, and assigns and will be construed and governed by the laws of the State of Colorado, except to copyright and trademark matters, which are governed, by United States laws.

**Venue/Jurisdiction.** Site for state court litigation must be in the State of Colorado, Gunnison County District Court.. Site for federal court litigation must be in the U.S. District Court for the District of Colorado.

**Severability.** Should any term of this Agreement be declared void or unenforceable by any court of competent jurisdiction, such declaration shall have no effect on the remaining terms hereof.

**No Waiver.** The failure of either party to enforce any rights granted hereunder or take action against the other party in event of any breach hereunder shall not be deemed a waiver by the party as to subsequent enforcement of rights or subsequent actions in event of future breaches.
